Mr. Levesque is counsel on all of the above traffic tickets. Mr. Padget has been appointed to defend the Constitutional Law question. I understand that Mr. Levesque will be filing a Constitutional Law. It is expected to involve a Charter challenge to *Languages Act* provisions that restrict his clients' ability to have a French language or bilingual trial on traffic tickets. It is unknown if there will be a Charter issue separate from the Constitutional Law question.

As the same issue arises with respect to all nine tickets, counsel requests that a Case Management Judge be appointed under section 551.1 to set filing deadlines for the applications, to hear the Constitutional Law question in Calgary on June 18, 2018 and, if necessary to hear any subsequent Charter applications if it applies to all nine tickets.
